Tom brought meeting to order, all three Supervisors in attendance: Tom Stull, Jr., Henry Hoffer, Dan Pribisco, and sec. Trudy Harkcom

Motion by Dan to approve last month's meeting minutes, Henry sec., all agreed

Motion by Henry to approve payment of all bills, Dan sec. all agreed

Public Comment: Michelle thanked the supervisor for doing patch repair on Camp Run Rd., also stated that the club will have their first race this Saturday. No other comment

New Business: Dan motion to open the 2018 Township budget talks, Henry sec. all agreed

Henry motion to approve the 2018 Minimum Municipal Obligation worksheet for the township pension bill. Dan sec. all agreed....2018 Pension bill will be \$37,938.00.

Motion by Henry to approve Resolution # 2017-8 for the 2018 Minimum Municipal Obligation for the 2018 pension bill. Tom sec. all agreed.

Motion by Dan to submit applications to the Westmoreland County Conservation District for a Low Volume road grant and a Dirt and Gravel road grant for the year 2018..... not sure yet on what roads....possibly Thompson rd. or Upper Tabernacle rd. for Low Volume project and Rock Canyon for a Dirt & Gravel project. Tom sec. all agreed.

Tom motion to authorize the township solicitor to advertise for a township ordinance for Donegal Township to join the Pennsylvania Municipal Retirement Systems Drop Plan... This plan allows the last three years of pre-retirement pension payments per month to be put into a savings account that can only be acquired if the retiree retires at the end of the third year. Dan sec. all agreed.

Fall Dumpster day possibly will be held on Sept. 30<sup>th</sup>.

Other New business: Henry motion to research option for township to opt into the UCC State Building Code. This will consist of the township hiring a third party inspection agency to do all state mandated building inspections on all new construction on both residential or commercial building in Donegal Township. Dan sec. all agreed.

Motion by Dan to look into buying a Skid Loader thru the Co-Stars state contract. Tom sec. all agreed.
