Meeting brought to order

Motion by Dan to approve last month's meeting minutes, seconded by Henry, all agreed

Motion by Henry to approve payment of bills, seconded by Dan, all agreed

Public in attendance: Marty & Earl Hinebaugh, Abe Wagner, Anthony Dellgross

Public comment: Anthony Dellgross stated his concerns on Roaring Run Road with the bridge being removed and replaced on County Line Road, he felt that a lot more traffic will be using Roaring Run Road, and a possible dangerous situation at the intersection of Roaring Run Road and Tannery Road, with traffic not knowing who stops at the stop signs.....Supervisors stated they will have township engineer look at the intersection and do a traffic study on how to make the intersection more safe.

Motion by Dan to approve Resolution #2018-7....to approve the Land Revision and Planning Module for the LHTC Office Building development. Henry seconded, all agreed.

Motion by Tom to approve Resolution# 2018-1....approving the Donegal Township Municipal Retirement Plan with the Pennsylvania Municipal Retirement System with up-date of plan and the adding of the DROP Plan for choice of how the retiree would like to receive his benefit. Seconded by Dan, all agreed.
